Only residents in Wards 1 & 5 can vote in the Spring Primary and 20 absentee ballots were sent. Smith stated we are doing a final accounting for WRS and the Health Insurance. Once complete we will start to cross-train with Executive Assistant and Deputy Clerk/Treasurer

Police Chief's Report: Chief Dregne reported that his training was extremely valuable. Our new Police Officer Alex Udelhoven started February 5, 2024. Chief Dregne also stated he ordered the new radios for the department. The old radios will become obsolete. Chief Dregne also wanted to discuss the Freymiller property clean-up. Chief Dregne has been trying to reach out and have a conversation with Freymiller but has not made contact to date. Chief Dregne will also discuss options with City Attorney Wood.
