Motion by Alder Brenda Kalish to approve request from Firecracker Run Committee for the following City assistance with their 5 Mile Run, 2 Mile Run and 2 Mile Walk:

- 1) Use of West Shelter at Kronshage Park from 6:00 am until 12 00 pm on July 4, 2017

DPW, Mike Reynolds, reported that Slag Slurry Seal prep work is completed; applying the seal will start Monday or Tuesday. Swimming Pool painting has been completed; had pool caulked for an additional \$765.00. A couple of signs along the WRTO Boat Landing Walkway will need to be relocated because they hang over the guard rail. City crews will begin street painting soon. A storm sewer collapsed on Mary Street; it may have been damaged during construction. No official action was taken.
