Regular Meeting of the Boscobel Common Council

Monday, May 7, 2018, 7:00 P.M.

A regular meeting of the Common Council of the City of Boscobel, Wisconsin was called to order by Mayor Steve Wetter.

The Certificate of Proof of Notice of Meeting was presented.

Motion by Alder Roger Brown to approve minutes of the April 16, 2018 Common Council meeting as presented. Motion seconded by Alder Gary Kjos. Motion carried.

Mayor Wetter opened the Public Hearing in the matter of petitioning the State of Wisconsin, Department of Transportation, for state and federal aid for improvements at Boscobel Municipal Airport. Airport Commission President, Peter James, explained that the Airport Commission is working on the Airport's six-year plan and that the plan includes the following projects:

- a) Construct hangars, including demolition of existing hangars;
- b) Develop Southwest hangar area including taxiways;
- c) Rehabilitate runway / taxiway lighting;
- d) Rehabilitate apron;
- e) Sealcoat and crack fill airfield pavements;
- f) Clear runway approaches as stated in Wis. Admin Code Trans §55;
- g) And any other necessary related work.

Members of the Airport Commission, Boscobel Common Council and community members discussed the general usage and operation of Boscobel Municipal Airport. All comments about the proposed projects were positive. No one, in person or in writing, had negative comments or was opposed to the proposed projects. Hearing no further discussion or questions;
